Regulations made by the Minister under Section 39 read with Section 24 of the Chemical Weapons Convention Act, No. 58 of 2007.

**REGULATIONS**

1. These regulations may be cited as Registration of Persons Dealing with Scheduled Chemicals Regulations, 2008.
2. Every person who is —
  - (a) a producer, processor, acquirer, consumer, transferor, importer, exporter or user of any toxic chemical or precursor set out in Schedule I, II or III to the Act, ; or
  - (b) a producer of any unscheduled discrete organic chemical,

shall, make an application for registration as such producer, processor, acquirer, consumer, transferor, importer, exporter or user to the Authority in Form I set out in Schedule A hereto.

3. In the case of a person who intends to deal with any toxic chemical or precursor set out in Schedule I, II or III to the Act, or any unscheduled discrete organic chemical in any manner specified in regulation 2, he shall make an application to the Authority one month prior to being engaged in such undertaking.

4. Every application for registration with the Authority shall accompany the relevant fee stipulated for in Schedule B to these regulations.

5. Upon receipt of the application together with the relevant fee, the Authority shall ascertain the information provided in the application for their veracity and shall issue a Certificate of Registration, which shall be displayed by the applicant in the office, or the business place of the applicant.

6. A Certificate of Registration under regulation 5 may be issued, where necessary subject to conditions, which shall be printed on the reverse of such Certificate. It shall be the duty of the applicant to abide by such conditions.

7. (a) Where a person registered with the Authority to carry on any one or more activities as a producer, processor, acquirer, consumer, transferor, importer, exporter or user of any toxic chemicals or precursor specified in Schedule I, II and III to the Act or a producer of any unscheduled discrete organic chemical or to deal with one or more of chemicals decides to carry on an activity or deal with a chemical other than that covered by the registration, he shall make an application in Form 2 set out in Schedule A to these regulations, to the Authority not less than 14 working days prior to carrying on such new activity or dealing with the chemical, as the case may be, to have the registration amended to include such activity or chemical as the case may be.

(b) An amendment to the registration shall be required where any substantial variation occurs in the purity level of a scheduled chemical specified in the register.

(c) Every application for an amendment of a registration shall be accompanied by a fee as stipulated in Schedule B.

8. The Validity of a Certificate of Registration shall be two calendar years :in respect of the activity and chemical specified in such Certificate and may be extended for a similar period on payment of such fee as set out in Schedule B to these regulations.

9. A Certificate of Registration may be cancelled by the Authority where -

(a) any provision of the Act or any regulation made thereunder or any condition subject to which the Certificate of Registration is issued is contravened or any direction issued by the Authority is not complied with ;

(b) any particulars furnished to the Authority are false or inaccurate or any relevant data is suppressed ;

(c) the registration is not renewed at the end of the period for which is was issued ; or

(d) the activity for the conduct of which the Certificate of Registration was issued has ceased for two years ;

However, prior to the cancellation of a Certificate of Registration the Authority shall afford the person to whom it was issued an opportunity to be heard.

10. Upon cancellation of the Certificate of Registration the person to whom it was issued or any person in whose custody it remains shall surrender such Certificate of Registration to the Authority.

REGULATIONS made by the Minister under Section 39 read with subsection (1) of Section 25 of the Chemical Weapons Convention Act, No. 58 of 2007.

### Regulations

1. These regulations may be cited as the Activity Data and Import and Export Clearance Regulations, 2008.

#### DUTY TO PROVIDE THE AUTHORITY WITH ACTIVITY DATA

2. Every person who has been registered with the National Authority for Implementation of the Chemical Weapons Convention (hereinafter referred to as “the Authority”) to carry on one or more of the activities as a producer, processor, acquirer consumer, transferor, importer, exporter or user in terms of Section 24 of the Act, shall provide the Authority substantially in Form 1 or Form 2 set out in the Schedule to these regulations, with the details on all past activities and all anticipated activities, as the case may be, concerning such scheduled chemical or unscheduled discrete organic chemical in respect of which the Certificate of Registration has been issued.

3. The detail report in relation to the past activities carried out during every year concerning any scheduled chemical shall be forwarded to reach the Authority not later than the end of January of the ensuing year.

4. The detail report in relation to any anticipated activity for the next year concerning any scheduled chemical shall be forwarded to reach the Authority not later than 15th September each year.

#### DUTY TO OBTAIN CLEARANCE FROM THE AUTHORITY

5. Every application of an importer seeking an Import Permit from the Controller of Imports and Exports to import any toxic chemical or precursor listed in Schedule I, II or III to the Act or any unscheduled discrete organic chemical shall first be forwarded to the Authority by such importer for clearance by the Authority.

6. Every application of an exporter seeking an Export Permit from the Controller of Imports and Exports to export any toxic chemical or precursor listed in Schedule I, II or III to the Act or any unscheduled discrete organic chemical shall first be forwarded to the Authority by such exporter for clearance by the Authority.

7. An End User Certificate (EUC) shall be submitted to the office of the Director, National Authority for the Implementation of the Chemical Weapons Convention prior to any exports to any State not party to the CWC, of schedule I, II chemicals.

8. The Authority shall grant clearance for the import or export, as the case may be, of chemical by stamping an endorsement to that effect, conspicuously on the face of the application denoting the validity period and the date of clearance, upon satisfying itself that the applicant was registered with the Authority in respect of the chemical for the import or export, as the case may be, of which he seeks to obtain a permit from the Controller of Imports and Exports.

9. Where the Authority finds that the importer or the exporter has not registered himself with the Authority or has not registered for that specific chemical which he seeks to import or export, as the case may be, the Authority shall require him to register with the Authority before granting him the clearance.
